

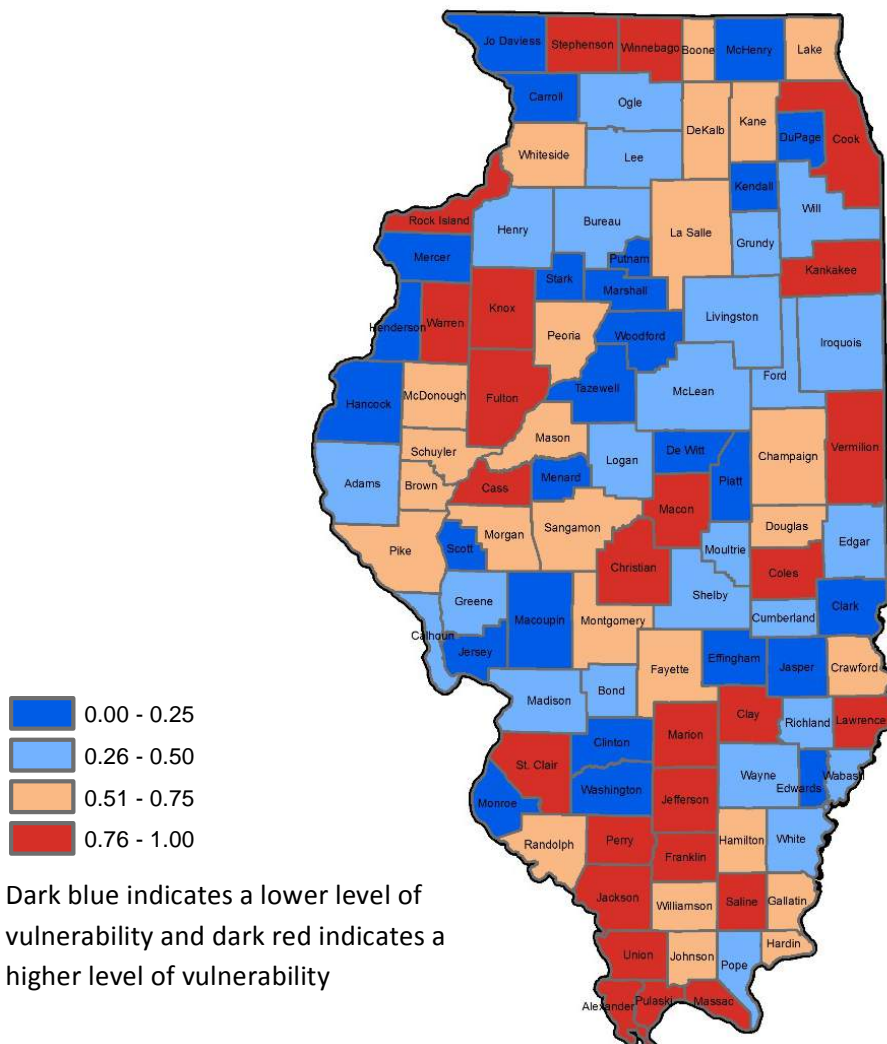
## Toolkit Addendum for Egyptian County Health Department

In addition to the suggested strategies and tools to strengthen existing heat illness prevention methods, this addendum provides information specific to Egyptian County Health Department to further assist your LHD in planning for extreme heat events. Included in this section are the following:

- Social vulnerability Index maps
- Heat hospitalization numbers and rates

### Social Vulnerability Index Maps

The Center for Disease Prevention and Control's (CDC) Agency for Toxic Substances and Disease Registry (ATSDR) developed the Social Vulnerability Index (SVI). The SVI is a geospatial tool that was developed to help emergency response planners and public health officials identify and map the communities that will most likely need support before, during, and after a hazardous event. Using 2010 Census Tract data, it breaks vulnerability down into four themes – housing composition, socioeconomic status, minority status/language, and housing/transportation. It then combines the four themes to assess an area's overall vulnerability. Below is a map of the overall vulnerability for all counties in Illinois and maps of the four themes and overall vulnerability specifically for Gallatin, Saline, and White Counties. 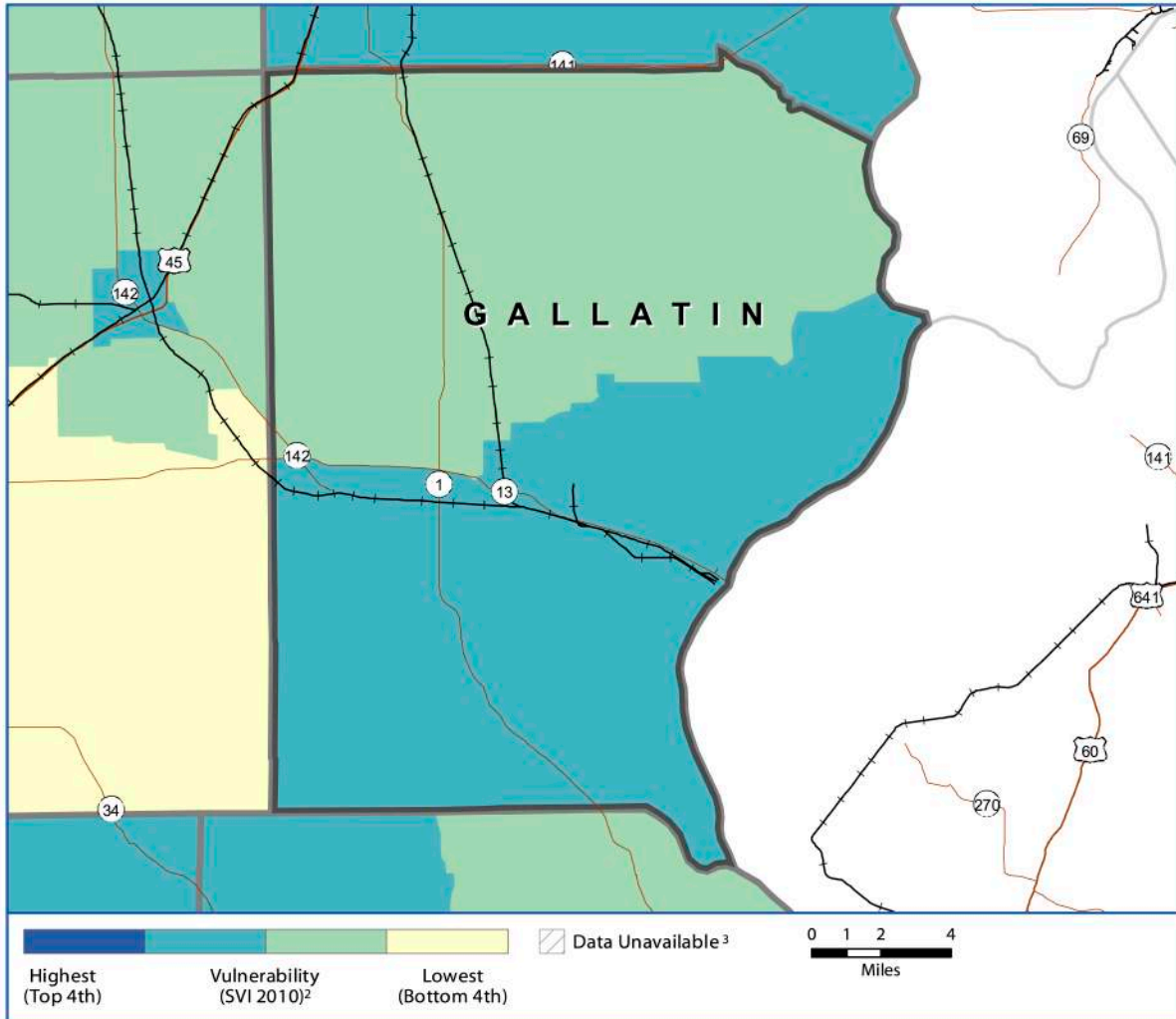

## Overall Social Vulnerability<sup>1</sup>



**Social vulnerability** refers to a community's capacity to prepare for and respond to the stress of hazardous events ranging from natural disasters, such as tornadoes or disease outbreaks, to human-caused threats, such as toxic chemical spills. The **Social Vulnerability Index (SVI 2010)<sup>4</sup> County Map** depicts the social vulnerability of communities, at census tract level, within a specified county. which the area is socially vulnerable to disaster. The factors include economic data as well as data regarding education, family characteristics, housing, language ability, ethnicity, and vehicle access. Overall Social Vulnerability combines all the variables to provide a comprehensive assessment.

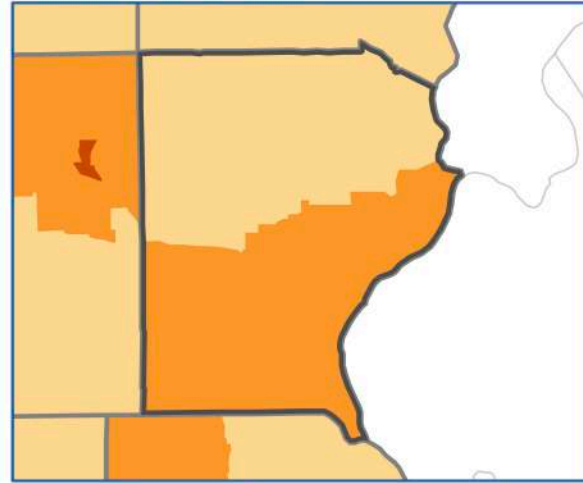

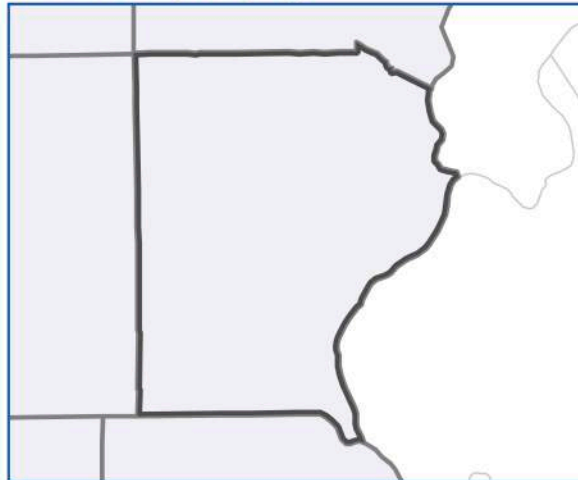
Socioeconomic Status<sup>5</sup>



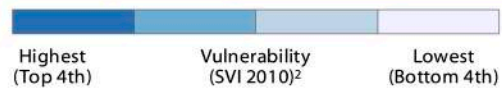
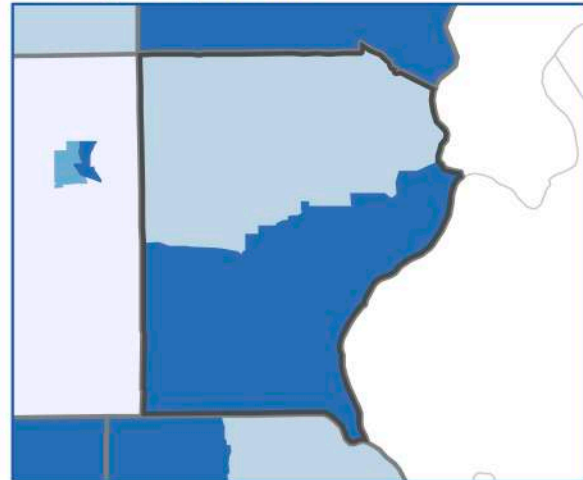
Household Composition<sup>6</sup>

### **Heat Illness in Gallatin County, Illinois**

Data from IDPH show that between 1987 and 2014, 11 people in Gallatin County were hospitalized for heat illness. The population of Gallatin County was 5,589 in the 2010 census. The rate of hospitalization for heat illness in Gallatin County is 6.10. This is more than double the rate of Cook County, where the devastating 1995 Chicago heat wave occurred in which over 700 people died.

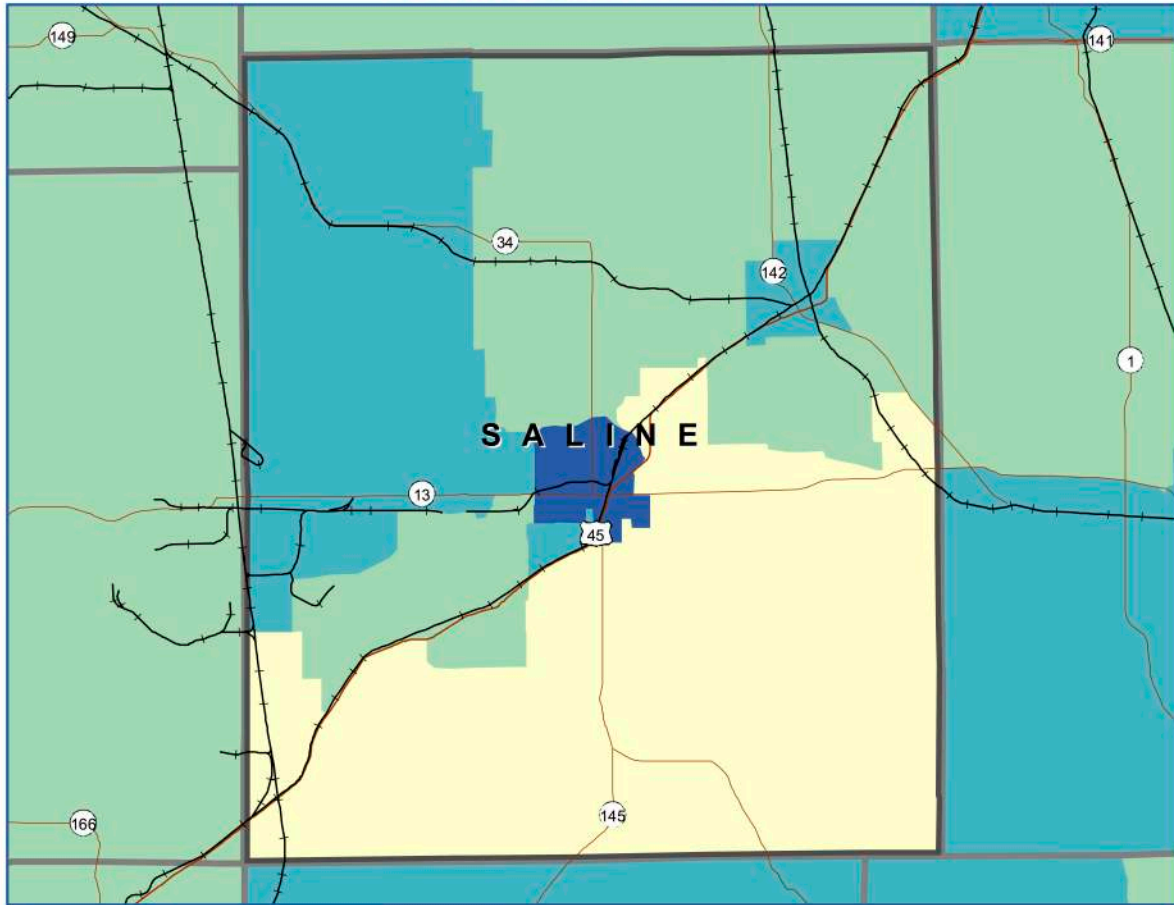
The known risk factors for dying of heat stroke include living alone, lack of air conditioning, being elderly, and having chronic medical and psychiatric conditions. Doing strenuous work outdoors in the heat also puts people at risk for potentially fatal heat illness.

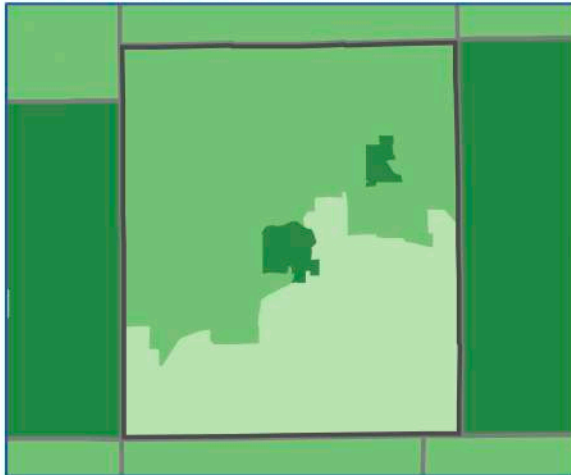

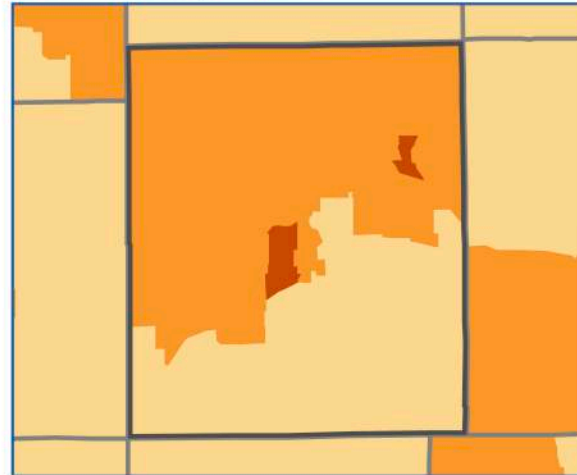

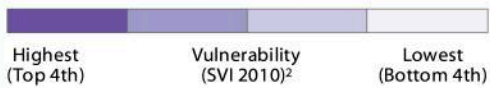
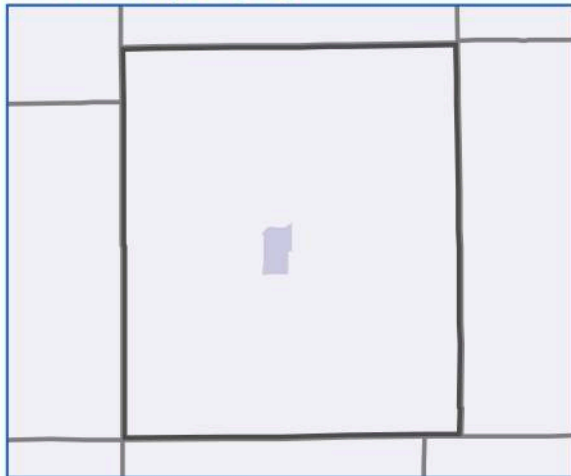
Socioeconomic Status<sup>5</sup>



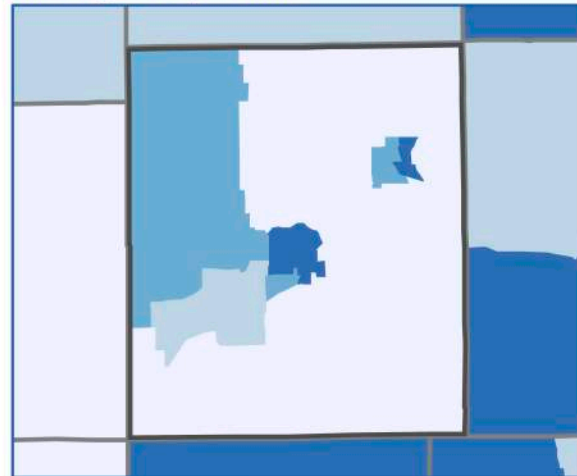
Household Composition<sup>6</sup>

The rate of hospitalization for heat illness in Saline County is 5.74. This is more than double the rate of Cook County, where the devastating 1995 Chicago heat wave occurred in which over 700 people died.

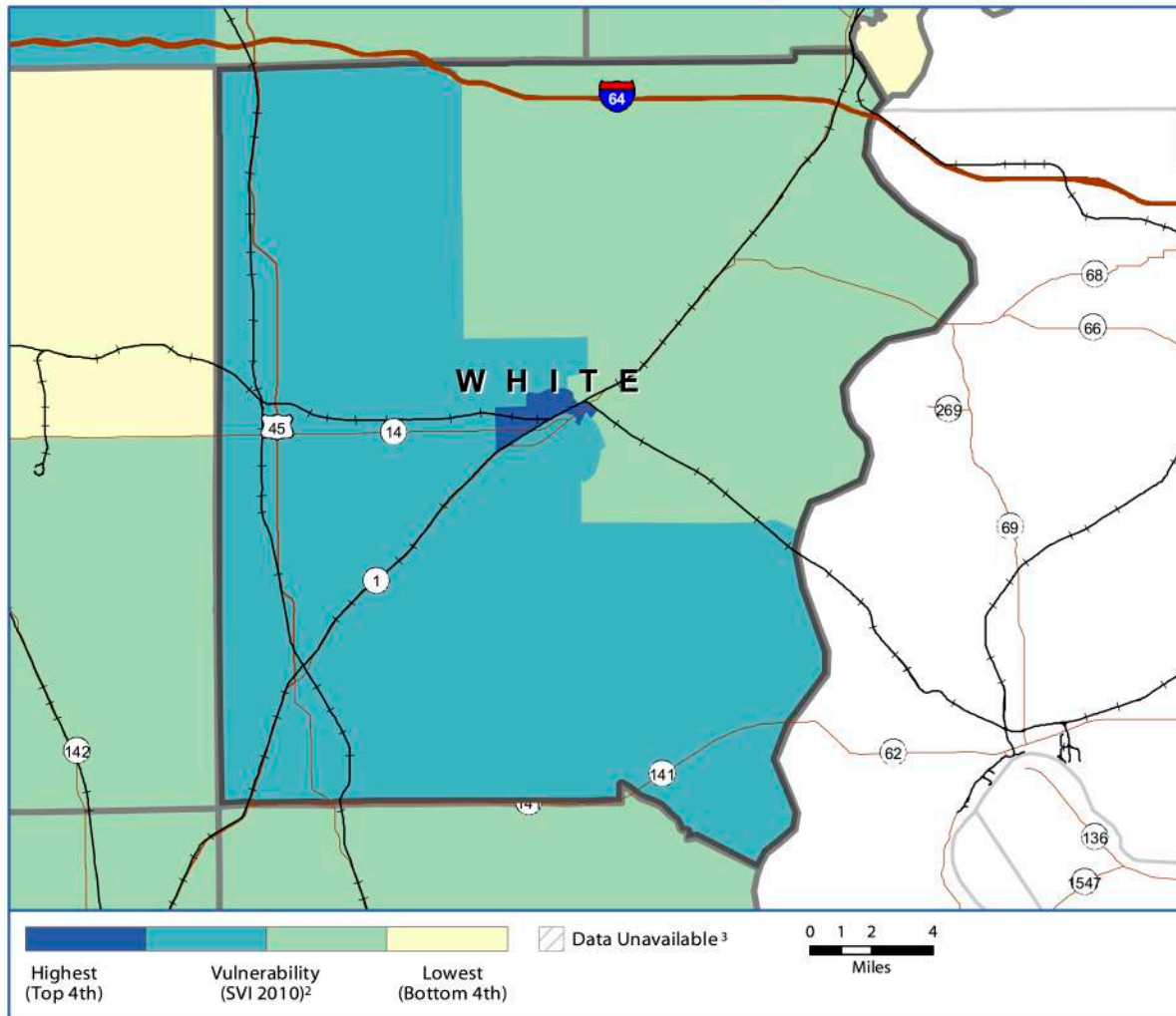

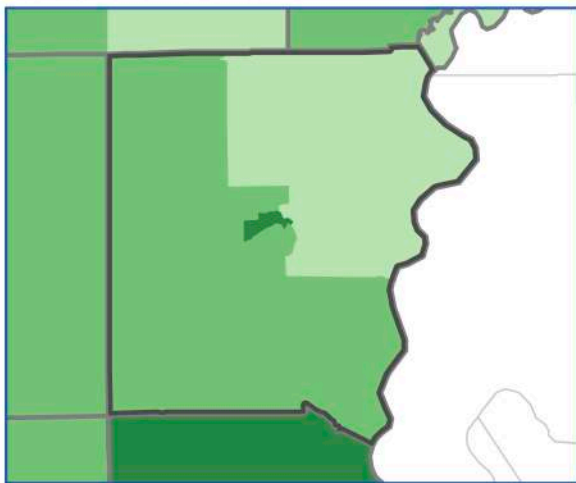

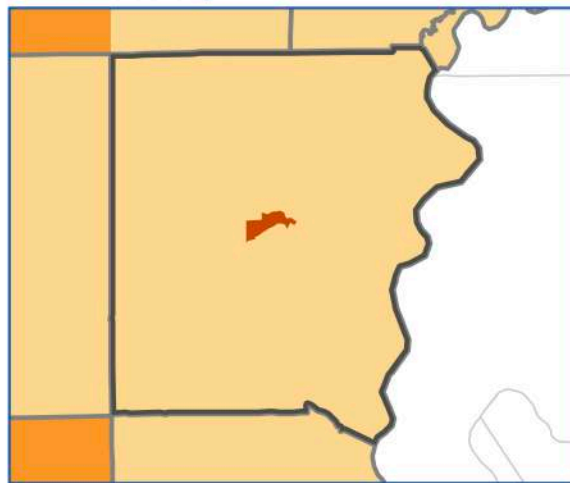

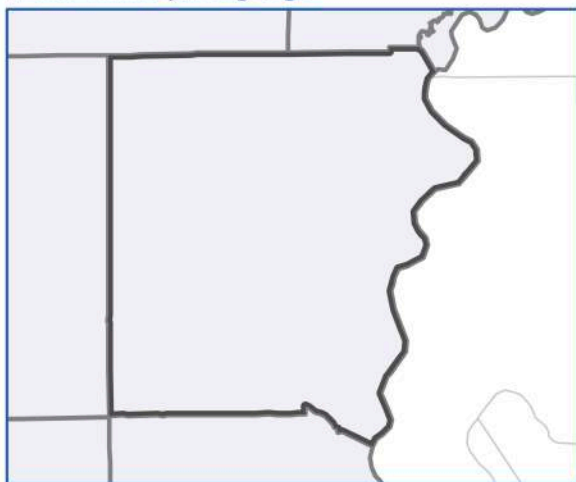
Socioeconomic Status<sup>5</sup>



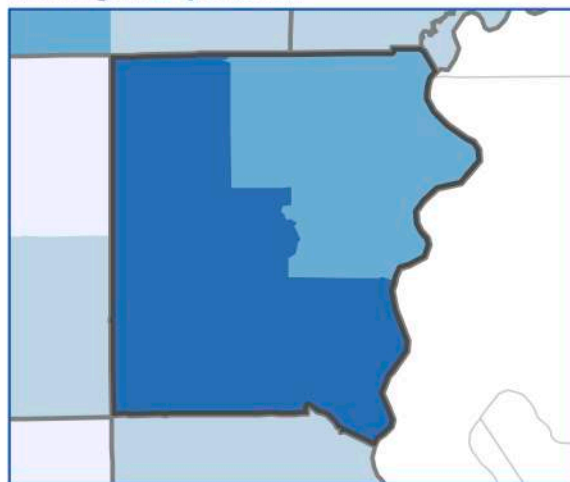
Household Composition<sup>6</sup>

Data from IDPH show that between 1987 and 2014, 9 people in White County were hospitalized for heat illness. The population of White County was 14,665 in the 2010 census. The rate of hospitalization for heat illness in White County is 2.09.

The known risk factors for dying of heat stroke include living alone, lack of air conditioning, being elderly, and having chronic medical and psychiatric conditions. Doing strenuous work outdoors in the heat also puts people at risk for potentially fatal heat illness.
